Purpose

Being a responsible and environmentally aware company contributing to a better future for our planet is our goal. We strive to minimize our environmental impact by using resources in a smart way and reduce our emissions to air, water and ground.

Compliance and Regulations

We abide by all the regulatory requirements for our operations, and we fulfill our clients' requirements for environmental standards.

Reuse and recycling

We are committed to integrating environmentally friendly products and practices into our operations. Our goal is to extend product lifecycles through reuse, refurbishment, and recycling, while maximizing resource efficiency. This approach supports the transition towards a circular economy by minimizing waste and promoting sustainable material flows.

To support the transition to a circular economy, we collaborate with suppliers to prioritize recyclable and sustainable materials where we can. Internally, we actively monitor and measure the outcomes of our reuse and recycling efforts to ensure continuous improvement and transparency in reducing waste and promoting sustainable material flows.

Chemical management

We only use a small amount of chemicals in our cable harnessing production. They are being handled according to the regulations. Our procedures for waste management and handling of hazardous materials must meet the minimum legal requirements. When possible, we should always use chemicals with the lowest impact on the environment.

Sustainability Practices

We are committed to continuously improving the environmental performance of our products, services, and operations. Our goal is to reduce energy consumption and waste generation, striving for increased resource efficiency.

Energy efficiency

We are committed to decarbonization in line with international climate goals like the Paris Agreement. We invest in renewable energy sources, such as solar and wind, and use renewable energy.

As of January 1, 2025, we will offset the carbon emissions from our district heating in collaboration with our provider, following the internationally recognized Gold Standard. This initiative underscores our dedication to sustainability by supporting certified climate projects that drive meaningful environmental impact, aligning with our commitment to reducing our carbon footprint and promoting a sustainable future.

Elproman follows our mother company KAMIC's ambitions to continuously reduce the negative environmental impact of business trips. When selecting new cars, we carefully consider their environmental performance, including emissions class, CO2 output, fuel type, and consumption, alongside safety features. Our goal is to continuously reduce the carbon footprint of our car fleet. We only provide vehicles with CO2 emissions under 60 grams per kilometer (WLTP), focusing on climate-friendly options. The policy will be updated as needed to align with new regulations.

GHG emissions

We are committed to reducing CO2 emissions across all business activities, with a focus on smarter logistics and consolidated shipments to lower the carbon footprint of our transportation. This not only minimizes shipping-related emissions but also aligns with our broader goal of achieving carbon neutrality by 2050, aligning with the goals of the Paris Agreement.
